### Terms and Conditions

I hereby apply to become a member of Global Wealth Trade Corporation (hereinafter referred to as GWT) and to participate in its Variable™ Business Plan. As a member, I understand and agree that:

1. I am of legal age in the jurisdiction in which I enter this agreement.
2. I shall become a Retailer or a GWT member upon acceptance of this application by Global Wealth Trade Corporation, depending on my application and the payment available. I certify that I have read and understand this Agreement, including Application, Terms & Conditions, Policies & Procedures and Variable™ Business (Compensation) Plan. I acknowledge that these documents are incorporated as part of my agreement in their present form, and as modified from time to time by Global Wealth Trade Corporation; these documents are available from the GWT Head Office. I also understand that I may not rely on any representation made by any member, whether verbal or written, regarding this Agreement, as the basis for a claim of misrepresentation against Global Wealth Trade Corporation. GWT will process your application at the package you request, and if not approved, the next level down and so on.
3. **Retailer:** If I chose the Retailer option, I may purchase products at the Retailer preferred price (25% higher than the member price) and retail them, I will receive Retail Profit cheques for orders placed through my website less 25% cost to use the website and shopping cart, and I will receive a Wholesale Profit cheque when someone I refer to GWT joins with a product package. This fee is non-refundable, and while I can upgrade at any time by paying for a product package in full, the fee cannot be used towards any package price. A Retailer can also choose to make monthly contributions to their SAC (shopping account) however while accumulating group volume, they will not earn commissions or bonuses.
